## Message from the President/CEO

In a lot of ways, 2014 was a good year for ChildSafe. I know it may seem strange to talk about a good year, given the fact that we are working with children who have experienced the trauma of abuse, but let me share with you why this year was good.

#### We were busy!

We served more children and their non-offending family members than ever before, providing them exceptional trauma focused care. Our counselors provided 2,403 counseling sessions to children and their non-offending family members and our family support specialist assisted 1,409 families. Along with Texas State University and

the Hogg Foundation we collected valid, useful, and positive data about our nationally recognized Adventure Therapy Program. Our education and prevention team trained over 10,000 professionals, parents, and youth about awareness and prevention of child abuse and self-protection.

In addition to our education and prevention work, last year we launched our Cardboard Kids® campaign to create awareness throughout our community about the often unspoken problem of child abuse. This campaign reached over 1 million people through social media alone. As a result of our education and awareness efforts, we accomplished something that has never been done before in the history of ChildSafe's 23 years of operation. From February 2014 through November 2014 we had 321 families come in or call for information or services. And, the number continues to grow. Prior to February 2014, ChildSafe's records show less than 5 families coming in on their own. Throughout our prior history, families and their children came through our doors as a result of referrals from law enforcement or Department of Family and Protective Services. We are now reaching more people with our message, and families feel safe about calling ChildSafe.

Both our new and ongoing donors were very generous to ChildSafe. In 2014, we received our largest individual gift to date from Azteca and Thomas J. Henry. The Henrys very generously gave us a gift of \$350,000, which will enable us to design and establish our first ever web-based training site. Our team is working diligently to get our new bilingual website up by May of this year. Our first training video, Recognizing and Reporting Child Abuse, will be available in both Spanish and English for all school employees. The Texas Education Agency (TEA) mandates all school employees complete this training once a year, and ChildSafe is making it convenient and easy for them to do so. We are working with Region 20 Education Center to reach all the 81 independent school districts and charter schools in their region. Our goal is to train the over



60,000 school employees in these 81 school districts and charter schools in the next school year. We will also be providing a similar training in both English and Spanish on our website for the students' parents in these school districts.

In addition to all the outstanding work our staff did in 2014, our board of directors was also working hard donating their time, talents, and treasures. Our board and leadership team are aggressively working on the new strategic plan initiatives - New Building, Fundraising, Awareness, Board Development, and Volunteer Ambassador Program. Art Wilson, an independent consultant, has been our amazing leader extraordinaire throughout this process. We are also expanding our Advisory Council and its involvement under the skilled leadership of our newest guardian angel, Doug Cross. We are all very honored and excited to have Doug on our team.

2015 will also be a good year! We will serve more families and children and reach more individuals through our education and prevention programs. We will solidify our new building plans as

we identify a new home for ChildSafe in a more central location to better serve our clients' and partners' needs. We plan to begin a capital campaign in the latter part of 2015 with a goal of moving into a larger facility in 2017. We will continue our Cardboard Kids campaign again this year hoping to reach many more residents of Bexar County, and

work with our community leaders, funders, and partners to engage our entire community to help stop child abuse.

We hope you all will support or continue to support our work and join us in changing our community as we move forward toward our extraordinary goal of eradicating child abuse and protecting our most valuable resource...our children.

## **Eradication Through Education**

In 2014 alone ChildSafe's growing education department provided training to over 10,000 educators, professionals, students, and caregivers. Together we can make a difference.



With demand for our prevention and education programs continuing to grow, we added two staff members to our department this past year, Gladys Amador, Education Team Leader, and Christina Polanco, Education Specialist. Together we were able to train over 10,000 individuals in calendar year 2014. These individuals ranged from educators, law enforcement mental health professionals, nurses, foster care workers/parents, Child Protective Services caseworkers, university students, parents, children, and other community members.

We have and continue to develop great partnerships throughout our community. Here are examples of recent outreach:

San Antonio Police Department: We were asked to participate in a state mandated, year-long in-service training for sworn members of the Department. The focus of the training was "Special Investigative Topics" and we provided weekly classes, discussing ChildSafe's services and training on child sexual abuse issues. These day-long trainings were in conjunction with Center for Miracles, Department of Protective and Family Services, Family Violence Prevention Services, and Rape Crisis Center every Monday for the year. As a result our team trained 2,350 SAPD employees.

#### Haven 4 Hope and Winston School of San Antonio:

We are providing radKIDS<sup>®</sup>, our child empowerment safety course, to the children in residence at Haven 4 Hope and to all the students at Winston School. To date, we have trained 96 children



YMCA of Greater San Antonio: It is our goal to train all 1,500 Y staff in Stewards of Children, a 2 hour training on how to recognize, react, and respond to child sexual abuse. In addition, we are providing the Stewards of Children training to the parents participating in the Y's Precious Minds New Connections program. To date, we have trained 86 staff and 240 Precious Minds New Connection parents.

A major component of our education department is providing training to recognize and report child abuse to school employees. Since July, we have trained 3,366 school employees. We conducted our first nurse's symposium in October and successfully trained the over 90 nurses in attendance. In addition, we trained 1,668 school age students about internet safety focusing on topics such as: cyberbullying, sexting and online predators.

Through education about and how to recognize child abuse, we are empowering our community to take action — by reporting suspected child abuse and neglect, and, by talking with their children about how to keep safe. Only as a community can we eradicate child abuse and protect our children.

## We All Have a Role



Trauma informed care is recognizing that people often have many different types of trauma in their lives. People who have been traumatized need support and understanding from those around them. Often, trauma survivors can be triggered by well-meaning caregivers and community service providers due to the misunderstanding of the lasting effects of trauma. At ChildSafe we are working hard to educate our partners and our community about the impact of trauma on children, co-workers, friends, family, and even ourselves as frontline service providers. Understanding trauma is an important first step in becoming a compassionate and supportive community where traumatized

children can thrive and develop into healthy contributing adults.

Trauma comes to us in many different forms ranging but not limited to: child sexual and physical abuse, neglect, witnessing violence in the home and community, random accidents, or the unexpected loss of a loved one. Trauma exposure can also be acute or multilavered and chronic. As

a community we must better understand that traumatized children without proper intervention live with their traumatic experience which may lead to child traumatic stress (CTS), and CTS may have a lasting negative impact as children develop into adulthood. The utilization of early and effective evidenced based intervention or trauma informed treatments is the key to healthy development in traumatized children. These treatments will positively impact the long term trajectory of a child's development. Unattended CTS may impact a child's ability to learn, to build trusting relationships, to develop positive coping patterns, to make solid life decisions, and may later in life negatively impact their ability to parent their own children.

The community that surrounds our children - parents, teachers, law enforcement, judges, juvenile probation, child protective services, our district attorney's office, and other child serving organizations and nonprofits - must come together to understand the traumatized child's experience. We can no longer assist perpetrators of crimes against children in keeping child abuse taboo by refusing to have conversations about San Antonio's community problem with child abuse. These conversations change the culture of our community, they empower otherwise disempowered children to come forward and seek help. When they do come forward we must be prepared to refer them to trauma informed organizations and trauma informed treatment providers. We must understand that a traumatized child may recant a statement, may choose not to speak, may wait two years before telling, may act out, may become depressed and hurt themselves, may fail in school, and may themselves become a product of the justice system. We must understand that behaviors that helped a child survive a traumatic situation may work against them in the real world. This has to be a community effort: law enforcement, prosecutors, CPS, and children's advocacy centers; none of us can do this by ourselves. It is time to change the child abuse culture of our community by becoming trauma informed and working together. We all have a role in becoming trauma informed.

## FEAT Program Receives National Attention





ChildSafe's Family Enrichment Adventure Therapy (FEAT) Program continues to help our families heal and carve new paths in the field of trauma-informed adventure therapy. The FEAT program makes use of natural settings and adventurebased activities like camping and rock climbing to help families heal together from the effects of child abuse and neglect. Dr. Christine Norton, associate professor in the School of Social Work at Texas State University, with funding from the Hogg Foundation for Mental Health, has been studying the effectiveness of ChildSafe's family-based adventure therapy on trauma and family functioning. She presented ChildSafe's FEAT program at recent prestigious conferences: the Institute on Violence, Abuse and Trauma Conference in Hawaii, the Wilderness Therapy Symposium in Utah, and the Association for Experiential Education Conference in Tennessee.

What she found by using clinical assessments and focus groups was that, in general, ChildSafe services improve family functioning, whether the families participate in FEAT or not. FEAT families attributed this to adventure therapy; non-FEAT families reported that traditional counseling was the most important service they received. However, FEAT families (who also received traditional counseling services) reported greater communication, closeness and problem-solving skills gained through adventure therapy. They also reported a faster return to normalcy, and a greater sense of empowerment and healing than non-FEAT families. Focus group participants reported that FEAT enhanced family behavioral and skill building, adding that participating in adventure therapy events with other families affected by trauma was a powerful part of their healing.

When comparing the results of the Trauma Symptom Checklist for Children, we found that children and adolescents who participated in FEAT experienced a significant decrease in trauma symptoms, particularly depression and anxiety — more so than those who did not participate in FEAT activities. While more research is needed, this study begins to build a foundation for trauma-informed adventure therapy as an innovative and effective intervention for children and families who have experienced abuse.

To help more families participate in FEAT, ChildSafe welcomed Annette Pelletier, MSW, as ChildSafe's Adventure Therapy Coordinator, a new position to the agency. She brought with her impressive outdoor expertise as a Wilderness First Responder and wilderness trip guide, apart from her experience as a social worker. Annette is proving to be instrumental in enhancing the program. For example, as she teaches families how to build fires using flint and steel or bow drills, she engages them in conversation about finding sparks in life after trauma and the fuel which keeps them moving forward together.

Having Annette on-board also allowed me to advance the program on other levels. For one, I was able to finish a handbook describing how FEAT lines up with established trauma-informed approaches to treatment and care. This tool is now available for other agencies serving children that are hungry for resources which engage children and families emotionally, mentally, and kinesthetically to address the resolution of trauma symptomology. I was also able to present a professional development intensive session with Dr. Norton, Dr. Anita Tucker, Dr. Bobbi Beale, and Nicholas Magle-Haberek, MSW, during the 2014 Association for Experiential Education Conference. Mental health clinicians from all over the country came to learn from us as leaders in the field of therapeutic adventure, leaving with new information and an appreciation for implementing trauma-informed practices during therapeutic adventure programming.



Just as wildflowers begin to bloom and spring is upon us, we will launch ChildSafe's community-wide child abuse awareness campaign—Cardboard Kids. This second annual event will be held in April which is National Child Abuse Prevention Month.

Thousands of Cardboard Kids will be decorated and then placed all over San Antonio on Thursday, April 9, 2015. Each Cardboard Kid represents a child victim of abuse and neglect in Bexar County—both those who have made an outcry and those who continue to suffer in silence.

In 2013, 5,846 children were confirmed victims of abuse and neglect in Bexar County. This staggering statistic is made even starker by the fact that for every child who makes an outcry, 10 more are silent, stifled, scared or threatened into not telling an adult about the abuse they are enduring. That is why there will be so many Cardboard Kids cloaking our city on April 9.

Cardboard Kids will make their way onto playgrounds, into coffee shops, grocery stores and more, and the creators of each Cardboard Kid will share photos of them using social media to heighten attention, intervention, and prevention of abuse and neglect of children in our community.

Citizens, companies, and organizations are being asked to join in this effort by picking up a Cardboard Kid during our distribution weekend March 13–15 and begin decorating them. Then on April 9, participants will place their Cardboard Kids all around the city and take a photo of them to share via social media using #cardboardkidsSA on Twitter, Instagram, and Facebook.

We created Cardboard Kids to illuminate the pervasiveness of child abuse and illustrate the fact that every story is different and every child unique.

## A Mission Worth the Investment



In the short amount of time I have been with ChildSafe, I have completely come to love the purpose and mission of this agency. I realize that I'm not the only one. The staff here at ChildSafe is truly committed to the mission of providing quality, traumainformed service, and this makes for a dynamic, intelligent, and highly motivated team.

The number one goal of ChildSafe is to provide the absolute best services to children traumatized by abuse and neglect, as well as to their non-offending family members. My role in this meaningful mission is to help ensure we have the financial means to do just that.

Innocent children, whose lives have been traumatically altered by the abuse or neglect they have endured, are 59% more likely to be arrested as a juvenile, 28% more likely to be arrested as an adult, and 30% more likely to commit violent crime and often go on to suffer from mental illness, alcoholism, and a host of other physical problems. This comes at a tremendous cost to our community. According to a 2008 Centers for Disease Control report, the lifetime cost per substantiated case of child abuse is \$210,000. This includes immediate costs, loss of productivity, and increased health care costs into adulthood and does not include inflation for recent years. It is estimated that child sexual abuse costs the U.S. \$124 billion each year.

Last fiscal year ChildSafe served 3,846 children and nonoffending family members at a cost of \$424 per client. What is just as important is that these children were able to reclaim their childhood and go on to develop into healthy, contributing members of our society. Ultimately, this is a result worth the investment.

Through the generosity of our donors, we have been able to ensure our ongoing efforts of impacting our community one child at a time.

ChildSafe also seeks to cultivate a community of likeminded individuals and connect with those who believe in giving children every opportunity they deserve to recover and flourish.
