



Messages from the CEO & Board Chair

CHILDSAFE TO THE NEXT LEVEL

As I look back on this last year, I am amazed at what the ChildSafe team accomplished. Our team provided exceptional, cutting-edge services to more children and their non-offending family members than ever before. We touched over 3,200 clients, helping them recover and heal from the devastating trauma of child abuse. We are also providing more training and education than ever before to school employees, teachers, law enforcement, human service and mental health professionals, and parents. We are partnering with the YMCA of Greater San Antonio to provide child sexual abuse preventive education to their staff and their 46,000 members. Our first year pilot for this partnership will get underway January 2014 in the YMCA's five early learning centers.

ChildSafe had two therapists complete their training to become the first nationally certified Trauma Focused Cognitive Behavior Therapists in our community. We were honored, in conjunction with Texas State University, to be awarded a Hogg Foundation grant for one of our programs that is the only one of its kind in the nation being done at a Children's Advocacy Center. And our entire clinical department was selected to participate in specialized training at Yale University.

With funds received from the Harvey E. Najim Family Foundation and The Greehey Family Foundation we were able to do renovations to create a forensic interview wing. We now have three forensic interview suites and adjacent office space for our forensic interviewers. Also, with funding from The Charity Ball Association we were able to give our waiting areas a fresh look and provide more privacy for families and their children as they wait to meet with their Family Support Specialist, Therapist, or Forensic Interviewer.

We are also growing our numbers of individual supporters. We began the *Legacy Circle* this year and celebrated our first membership event at the home of and generously underwritten by Deborah and Morris Miller.

SPREAD THE WORD

This year at ChildSafe, we've expanded services, formed new partnerships and enhanced our practices to make certain the children of Bexar County receive the best care possible as they tackle abuse and neglect with our highly-trained staff and partners. Unfortunately, the number of children and families we serve continues to increase—a disturbing indicator that our most vulnerable citizens, our children, are under significant stress due to exploitation.

In February, we announced that ChildSafe expanded its mission to treat children traumatized by all abuse. Now the organization provides comprehensive services to children that have been physically abused and neglected, as well as continuing our mission of providing treatment to children who have been sexually abused. While we continue to make forward progress, the ChildSafe administration and board have set an ambitious agenda for taking the agency and its services to the next level for 2014. We are focusing on building our donor base, expanding our prevention and education programs, finding a permanent location that is more convenient for our partners and clients and building our brand recognition so that families in our community know who we are, what we do and that we are there for them in times of crisis.

Child abuse and neglect are issues that must be fought at the local level and that need the attention of the community at large to initiate change. How can you get involved and help stop child abuse in Bexar County?

Share information about ChildSafe and our education programs at your place of employment, with teachers, administrators, PTAs, coaches, Boy and Girl Scout troops, daycare centers, church youth groups—settings where kids spend time with adults! 

ChildSafe counselors honored by invitation to participate in training for new therapy at Yale University





A LEADING AGENCY FOR CARE

ChildSafe is extremely excited about the opportunity to continue to grow as a leading agency in treating traumatic stress in children in the San Antonio community. ChildSafe is one of two CACs in the nation selected by the National Child Traumatic Stress Network (NCTSN), the National Children's Alliance (NCA), and Yale University to participate in training for a new up and coming trauma specific treatment modality: Child and Family Traumatic Stress Intervention (CFTSI). ChildSafe will be the first CAC in Texas to implement the model and only one of a handful in the nation.

CFTSI is brief intervention treatment developed at the YALE Child Study Center and University of Pennsylvania for children recently exposed to a potentially traumatic event. CFTSI is centered on the concept that caregiver support is one of the most significant factors in supporting a child in recovery after experiencing a traumatic event. It is a family systems treatment model which last 4-6 sessions. CFTSI aims to increase family support for the affected child by increasing the family's understanding of the child's reaction to trauma, increasing family communication, and teaching the caregiver child behavioral interventions to reduce acute post-traumatic symptoms and reactions prior to the development of posttraumatic stress disorder. The model is designed for children ages seven and above. CFTSI has shown success in children who have experienced a wide range of traumatic events including physical and sexual abuse, assault, witnessing domestic and community violence, motor vehicle accidents, animal attacks, and other injuries. CFTSI can be implemented shortly after the event or in the wake of later disclosure of a traumatic event that occurred earlier in a child's life, such as sexual abuse. All full-time counselors at ChildSafe participated in the training held at YALE University November 21-23. ChildSafe expects to implement the model in early December.

In addition to CFTSI, ChildSafe employs two full-time counselors who will complete their national certification in Trauma Focused Cognitive Behavior Therapy (TFCBT). Our two counselors have participated in a year-long learning collaborative that consisted of online training, an intensive 2-day face-to-face training with one of only 12 nationally certified trainers in TFCBT, and year-long monthly supervision with the trainer. TFCBT and CFTSI fit ChildSafe's belief that early intervention is key to healthy long-term development in traumatized children.

Studying the Effects of Adventure Therapy

A FEAT NOT TO BE UNDERSTATED

Camping, kayaking, rock climbing, archery and other outdoor adventures—all unique therapies offered to children and families affected by abuse and neglect treated at ChildSafe—are now the subject of a new study by a local researcher.

ChildSafe's CARE & Adventure Therapy Manager, Federico A. Borroel, LPC-S, founded the Family Enrichment Adventure Therapy (FEAT) program in 2009 with a grant awarded from Texas Parks & Wildlife. He is a Licensed Professional Counselor who has designed FEAT to help ChildSafe clients connect with one another, the outdoors, and other families healing from the effects of child abuse and neglect. Families often report value in participating in outdoor activities together for the first time as a way of strengthening their relationships, recognizing interpersonal strengths, and witnessing courage in one another.

"The stories I hear from children and families participating in FEAT amaze me. I've learned about the powerful resiliency of people overcoming the trauma of child abuse and this has proven to be one of the most rewarding aspects of the work I do at ChildSafe," said Borroel.

Now, the program will be examined by noted researcher Dr. Christine Norton, assistant professor in the School of Social Work at Texas State University. She is embarking on a study that examines how FEAT, offered to child clients and their supportive family members, might reduce the effects of PostPrestigious grant from the Hogg Foundation for Mental Health underwrites FEAT study led by noted researcher, Dr. Christine Norton, in partnership with ChildSafe

Traumatic Stress Disorder (PTSD) and other mental health issues for children who have been sexually or physically abused and/or neglected.

Norton's study is made possible by a \$19,250 grant from the Hogg Foundation for Mental Health received this past June.

"By studying the efficacy of family-based adventure therapy interventions on trauma and family functioning, this research will contribute clinically relevant and evidence-based information to mental health providers and the general public regarding the range of treatment options available to children and families affected by abuse and neglect," said Norton.

Norton will study 30-50 family clients of ChildSafe to determine if adventure therapy is an effective mental health intervention for child survivors of physical and sexual abuse and their families. Her study, which will take 6 months, will measure reductions in child trauma symptoms and improved family functioning.



"The implications of Dr. Norton's study should not be understated, as we believe adventure therapy will demonstrate strong benefits for children and families affected by abuse and has the potential to be a therapeutic model for other Children's Advocacy Centers in our state and country," said Kim Abernethy, ChildSafe CEO.

Families referred for traditional services at ChildSafe can elect to participate in FEAT, as well as "talk therapy" in individual, group and family settings. While outdoor adventure activities vary, the intent of each outing is solution-oriented as participants work together toward goals identified with one another either at the beginning of the activity or previously with their family's counselor or family advocate at ChildSafe.

Norton has numerous peer-reviewed journal articles in this area, and is the author of *Innovative Interventions in Child and Adolescent Mental Health*. She is an appointed Research Scientist with the Outdoor Behavioral Healthcare Research Cooperative.

WHAT IS EMERGENCY ASSISTANCE?

Child abuse is a traumatic experience for the whole family. Frequently the abuse results in displaced families in addition to the significant stress of the abuse itself. Emergency assistance is provided to our clients to help them access essential items and services when the family is in crisis. From clothing, shoes or hygiene products to mortgage assistance, bus fare, or help with utility bills, ChildSafe Family Support Specialists are there to help a family in need.

The items and support provided through Emergency Assistance are often basic items that most families take for granted. Sometimes the difference between whether a child can go to school is a simple pair of shoes. Feeling good about yourself can start with just a new hairbrush or your own hygiene products.

58% of the 1261 families served at ChildSafe who reported their income last year have a household income less than \$25,000.

Only 44 ChildSafe client families received Emergency Assistance through ChildSafe in 2013; lack of emergency resources and physical storage space hindered us from the ability to serve more families with this kind of help.

PROJECT TEACH

Project Teach (Training/Education on Abuse & Child Health) is a combination of brown bag workshops and case studies which provide information on child abuse, child mental health and related topics. Offered the second Friday of every month from 11:30 a.m. – 1 p.m, these trainings are provided by experienced professionals/content experts. The cost of each brown bag workshop is \$25. Case studies are \$30 per session.

CHILDSAFE PARTNERS WITH THE YMCA OF GREATER SAN ANTONIO

We are excited to announce our partnership with the YMCA. Together we realize the importance of working together to stop child sexual abuse. Child molesters are not strangers. In more than 90% of sexual abuse cases, the child and the child's family know and trust the abuser. One in 4 girls and 1 in 6 boys are sexually abused by the age of 18. Child molesters are drawn to organizations which serve youth.

The trainers in ChildSafe's Education and Outreach Department are certified trainers for *Stewards of Children*TM. *Stewards of Children*TM is a nationally recognized, evidencebased sexual abuse prevention curriculum created by *Darkness to Light*[®]. This training educates adults to prevent, recognize and react responsibly to child sexual abuse, and encourages them to act.

ChildSafe has initiated a pilot program with the YMCA's five early learning centers. All staff members and volunteers will be trained; and, parents will be offered the *Stewards of Children*[™] training. We will be working with the YMCA to expand the pilot program to all the YMCA sites in the greater San Antonio area to reach the 46,000 YMCA members.

CHILD WELFARE SERIES

"Let's Talk about Trauma" is an eight-part series on building a Trauma Informed Child Welfare System. This series aims to increase the knowledge and skills of child welfare workers so that they can effectively serve children and families who have experienced traumatic events. Classes will be held on the last Friday of every month from 1 p.m. - 3 p.m. Trainings will be conducted by ChildSafe's Director of Programs, Randy McGibeny, MA, LPC. The cost of each session is \$25.

All participants receive a General Certificate of Instruction. There is no additional fee for CEU credits (SW, LPC, LMFT only). Fee does not include lunch, but please feel free to bring one. Trainings are FREE for ChildSafe MDT (Multi-disciplinary Team) partners and half off to ChildSafe CARE (Child Abuse Resource Enhancement) partners.
